We calculate the Periodic Finance Charge by multiplying the Average Daily Balance for each segment by the segment's Daily Periodic Rate and then by the number of days in the billing cycle. To get the Average Daily Balance for each segment, for each day of the billing cycle we take the beginning balance, add any new transactions and charges (but excluding any Annual Fees and unpaid Finance Charges), subtract any payments and other credits to that segment and make any adjustments. A negative balance is considered to be zero. This gives us the Daily Balance. We then add up all of the Daily Balances for the billing cycle and divide that total by the number of days in the billing cycle. This determines the Average Daily Balance.

- **GRACE PERIOD:** You can avoid Periodic Finance Charges on Purchases if you pay the New Balance, in proper form, by the Payment Due Date stated on your periodic statement each month and if you also paid in full the new balance shown on your previous periodic statement by the Payment Due Date. You have no grace period in which to repay your balance for Cash Advances before a Periodic Finance Charge will be imposed.
